 - All PL-1 positions are filled through the **National Resident Matching Program (NRMP)**.

Your ERAS application must include:

- MSPE (Dean's Letter)
- Medical school transcript(s)
- USMLE/COMLEX transcript
- **Three (3) letters of recommendation** (one Department of Medicine letter preferred)
- Personal statement
- Curriculum Vitae (CV)

About the ROAP Track: Religious Observance Accommodation Program (ROAP)

The Internal Medicine Residency Program offers a Religious Observance Accommodation Program (ROAP) 3-year Categorical track. This program provides scheduling accommodations for individuals observing a recurring weekly religious obligation.

ROAP-track residents will complete all of the same rotations as residents not in the ROAP track. Schedules for those residents in the ROAP track may be different but are equivalent to those in the non-ROAP track. Accordingly, it is important to note that participation in ROAP does not provide accommodations for every religious holiday. The Internal Medicine Residency Program will make every effort to accommodate religious holidays for ROAP-track residents but there may be limited circumstances where the resident may be scheduled during a religious holiday. If a ROAP-track resident is scheduled during a religious observance, it is the resident's discretion whether to work or use any available paid time off.

Please note that ROAP only provides scheduling accommodations for religious obligations. It does not provide any additional paid time off entitlements. All residents should refer to the Collective Bargaining Agreement between Maimonides and Committee of Interns and Residents/SEIU for their paid time off benefits.

The program is structured to comply with ABIM (American Board of Internal Medicine) guidelines on time away from training, ensuring that residents meet the necessary training requirements outlined by ACGME (Accreditation Council for Graduate Medical Education). This ensures that participants remain eligible to sit for the boards while fulfilling both their professional and religious commitments.

Program Requirements

- **Visas:** As per guidance from our academic affairs, Maimonides Medical Center accepts the following visas:
 - J1

- Due to recent executive order affecting H-1B sponsorship and subsequent litigation, Maimonides Medical Center cannot guarantee H-1B sponsorship. H1B applicants must have **passed USMLE Step 3** by the NRMP Rank Order List deadline.
 - **USMLE/COMLEX Scores:** While there is no strict minimum score requirement, the number of attempts to achieve a passing grade is taken into consideration.
 - **Medical School Graduation:**
 - Preference for graduates within the past 3 years
 - Gap greater than 3 years must show **recent and relevant clinical experience**
 - **U.S. Clinical Experience:** Not required, but **strongly preferred**
 - **Track Selection:**
 - Candidates **must apply to only one** of the following:
 - Categorical or Categorical ROAP
 - Preliminary
 - Applications to both Categorical and Preliminary tracks from the same applicant will not be considered

Interview Day Format

All interviews will be conducted **virtually** in line with national guidelines.

Interview day typically includes:

- Program overview by the **Program Director**
- Welcome from the **Chair of Medicine**
- **Two one-on-one interviews** (faculty member and current resident, chief resident, or fellow)
- **Brief meeting** with the Program Director or designee
- **Interactive group session** with current residents

In partnership with peer institutions, **we will not offer in-person second looks** for this season. This aims to reduce financial and logistical burdens on applicants.
